How are we going to do it?

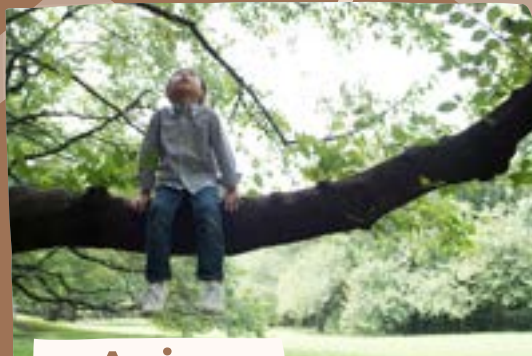

In our Summer Camp every week we will enjoy a journey through the continents.



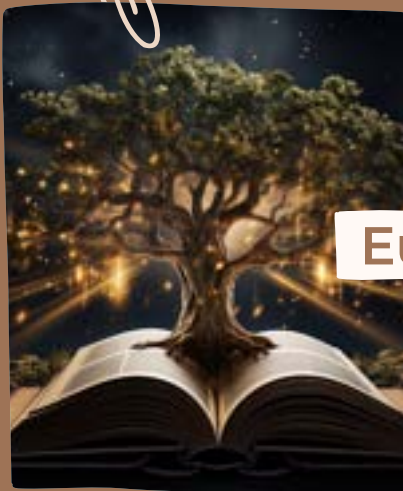

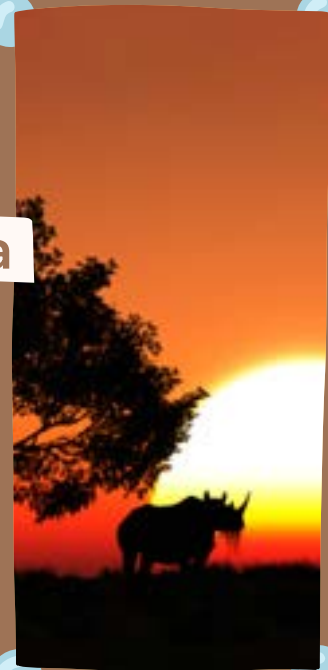
